### **Land Conservation**

**Funding for Natural Resources:** Virginia has strong voluntary conservation programs that have been responsible for the protection of hundreds of thousands of acres of open space, working lands and our most treasured natural and cultural resources. Yet Virginia is a long way from the goal of protecting 30% of our lands by 2030, with only about 15% of the Commonwealth protected. For many years, Virginia has only spent about one percent of available state revenues on natural resources, ranking near the bottom when compared to other states. In the last two years alone, unmet demand for Virginia Land Conservation Foundation Grants has exceeded \$100M. There have also been attempts to weaken the Land Preservation Tax Credit.

The 2020 Report of the Virginia Council on Environmental Justice outlined a number of recommendations to improve outdoor access for underserved communities.

**Wildlife Corridors:** Virginia's roads cover 70,105 miles, comprising the third-largest state-maintained highway system in the Country, cutting the Commonwealth's landscape into pieces and separating once-connected habitats. Providing wildlife corridors protect public health, reduce wildlife-vehicle collisions and make habitats and ecosystems more resilient on land and in water.

### Land Use & Transportation

**Clean Transportation Funding Models:** Transportation represents the largest source of carbon emissions in Virginia. In order to change that, we need a shift to a cleaner, balanced, and more equitable transportation system with an emphasis on reducing vehicle miles travelled and electrifying the remaining miles.

**Promoting Rail Initiatives:** Virginia has recently taken steps to expand Amtrak and VRE services, create a pathway for the separation of freight and passenger rail in Virginia, and preserve future rail corridors. The Commonwealth must continue to prioritize rail to reduce traffic congestion as well as carbon pollution.

Recent legislation established a Clean Cars Standard, identified infrastructure needs, and set up a framework for equitable EV rebates. Increased action and funding are needed to build on this foundation.

**Flooding & Resiliency:** Communities throughout Virginia are facing unprecedented challenges from rising seas, recurrent flooding, and increased precipitation and storm intensity. Virginia has begun taking much-needed steps to address our communities' growing vulnerability to flood events, but more work is needed.

**Toxics:** Emerging contaminants include "forever chemicals" known as PFAS. PFAS are found in nonstick materials, from cookware, raincoats, cosmetics, and firefighting foam. These toxics leach into our soil and contaminate our water. Once they enter the human body, these toxic substances build up, and can't be broken down. They have been linked to cancer, infertility, and other health impacts.

25. Will you support regulating the presence of emerging contaminants such as PFAS in Virginia waters and banning products containing contaminants of concern?

**Plastics:** studies have shown that the Chesapeake Bay, tributary rivers and streams, and its shoreline have a significantly high concentration of plastic pollution. Plastic litter has wide-ranging destructive impacts on human health, wildlife, water infrastructure, and agricultural land.

26. Will you support strategies to reduce consumption of single-use plastics?

**Uranium & Gold Mining:** Virginia has in place a more than 30-year-old moratorium on the mining and milling of uranium. Modern gold mining and onsite processing presents similarly toxic risks. According to the US EPA's Toxics Release Inventory, metal mining is the nation's #1 toxic polluter and multiple recent gold mines on the East Coast are federal Superfund sites. Chemicals like cyanide are used to extract minute pieces of gold from rock and 99 percent of the earth excavated becomes waste containing harmful contaminants like mercury, arsenic and lead that are stored on site in mounds or holding ponds, at risk of contaminating local ground and surface waters or becoming airborne. Insufficient funds are required to be set aside for reclamation, leaving low-income communities, communities of color and the Commonwealth at risk of picking up the bill to clean up the sites. A study is being conducted by the Department of Minerals, Mines and Energy, Department of Environmental Quality and Virginia Department of Health to examine the public health and environmental impacts of large-scale commercial gold mining.

Just Transition to Clean Energy: The last few General Assembly sessions yielded landmark victories for clean energy through the passage of the Virginia Clean Economy Act, the Solar Freedom Act, and grid modernization legislation. Work is needed now to build on this progress in a way that benefits all Virginians as we ensure a just transition to a clean energy future.

Equitably transitioning to a clean energy future and preserving Virginia's natural resources will require collaboration across disciplines from energy, commerce and trade, transportation, natural resources, public health, diversity and inclusion, and others.

Virginia's Constitution directs the Commonwealth "to protect its atmosphere, lands, and waters from pollution, impairment, or destruction, for the benefit, enjoyment and general welfare of the people". Despite this, Virginia's investment in its natural resources has been inconsistent and significantly lower than its peers. To address the climate crisis, the Commonwealth Clean Energy Policy establishes a policy of reaching net-zero emission by 2045 in the electric power, transportation, industrial, agricultural, building, and infrastructure sectors.
